Treasurer's Report

It gives me great pleasure to report to the annual general meeting of Graduate Women New Zealand of the financial results for the year ending 30th June 2024.

We have again been fortunate to have the services of Kevin Duggan offering an independent review of the report as appended at the end of the financial report. He has advised that the members need to formally agree (and minute that agreement) that the GWNZ Charitable Trust Financial Accounts do not need to be incorporated into the GWNZ Financial Accounts. This matter was reviewed at the first AGM after my appointment (see note on Non-consolidation on page 3). Generally Accepted Accounting practice requires that all entities under the control of the parent body need to be consolidated in the annual financial report. However, support for the continuation of this variance needs to be in the AGM minutes every year.

Our income remains stable this year, as per page 5 line 9. You may observe on the same page (line 13) that we expensed the first edition of the Centenary book - so capably edited and produced by our hardworking Secretary Vanessa Ward - and copies of these were given to Branches for them to either sell or give away as they decided. However, there has been a demand for this book and a second edition was printed; the balance to hand can be observed in the current assets on page 6 and the Note on page 8.

I will recommend to the Executive that we should also send a copy of the book *gratis* to public libraries in the 16 main centres in New Zealand, as it is a valuable resource for anyone who wishes to gain an understanding of the efforts of GWNZ to support women's advancement and education.

Volunteer support throughout GWNZ remains key to the continuing success of our operations and the considerable amount of monies which have been distributed by the Branches and the charitable trust of GWNZ are proof of the effective implementation of our purposes.

I move that

- 1. the GWNZ Charitable Trust Financial Accounts do not need to be incorporated into the GWNZ Financial Accounts.
- 2. the capitation for branches remains as in the previous year:

Statement of Accounting Policies

a) Legal Entity

Graduate Women New Zealand Inc. is an Incorporated Society operating in accordance with the Incorporated Societies Act 2022.

b) Basis of Preparation

Graduate Women New Zealand Inc. has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses of equal to or less than \$2,000,000.

All transactions in the Performance Report are reported using the accrual basis of accounting.

The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

c) Goods and Services Tax (GST)

Graduate Women New Zealand Inc. is not registered for GST. Therefore amounts recorded in the Performance Report are inclusive of GST (if any).

d) Income Tax

The only income tax expense for Graduate Women New Zealand Inc. is that charged on interest received and is deducted at source from each interest payment received in the year to June 2023. These revenues are reported net of tax. There was a small tax refund received at the end of June 2023.

e) Investments

Investments in Term Deposits are recorded at the book values (see Note 1).

f) Inventory

The remaining Inventory of 43 books as at June 30th from the second print run of the Centenary booklets (50 books) are valued at cost under Current Assets. Most of the first print run of 50 copies were distributed (with 11 copies to each Branch) for their sale or use by Branches to encourage a broad dissemination thereof.

g) Receivables

Both non-current and current receivables are recorded at historic value.

h) Bank Accounts and Cash

Bank accounts and cash in the Cash Flow Statement comprise cash balances and bank balances (including term deposits).

i) Changes in Accounting Policies

There were no changes in accounting policies during the current financial year.

Independent Reviewer's Report on Agreed-Upon-Procedures

Graduate Women New Zealand National Executive Responsibilities:

The Treasurer and National Executive are responsible for the preparation of financial reports which fairly reflects the financial transactions of Graduate Women New Zealand for the year ended 30 June 2024. They have requested that I undertake a set of agreed-upon-procedures with respect to these financial reports. This engagement excludes any inspection of, or opinion on, the non-financial information in these financial reports (e.g. Statement of Service Performance).

Basis of the Agreed-Upon-Procedures

I have carried out an engagement to cover these agreed-upon-procedures. The purpose is for members to receive a report on factual findings on the matters detailed below from an independent knowledgeable person. I disclaim any assumption of responsibility for the adequacy or otherwise of the procedures requested. Members must form their own conclusions from the agreed upon procedures performed and the findings reported.

The procedures were performed solely to assist you in evaluating the validity of the financial reports for Graduate Women New Zealand for the year ended 30 June 2024. I was required to:

- 1. Inspect the bank records for the year ending 30 June 2024 and check the bank account has been reconciled.
- 2. Obtain the invoices and receipts issued by third parties and check these have been correctly recorded in the accounting information system utilizing Xero Accounting Software, MYOB and Excel Spreadsheets.
- 3. From the accounting information system and bank statements, check that the items recorded therein for the year ended 30 June 2024 agree with the figures in the financial report.
- 4. Review Minutes of Committee/Executive meetings for the correct authorization of payments.
- 5. Check the prior year's results to ensure a) they are included correctly in the 2024 financial report as comparative information and b) to assess potential anomalies. An anomaly is defined as a figure that is more than 10% different from the results for the prior year.
- 6. Obtain your assurance that no commitments have been entered into that are not recorded appropriately in the financial reports.
- 7. To maintain records of checks of the above procedures.

With respect to these procedures (1-6) I found that these were all correctly recorded. With respect to item 7, I have maintained records of my work.

Because the above procedures do not constitute either an audit or a review, I do not express any opinion on the information contained in the annual report for the year ended 30 June 2024 other than as above. My report is solely for your information and is not to be used for any other purpose. Other than supporting the aims and objectives of the organization I have no special relationship that would give me an interest in Graduate Women New Zealand.
